Landscaping

Kyle stated that the landscaper had cleaned up the conservancy area between the houses and the golf course. He felt that they did an excellent job and it looks a lot better. Unfortunately, the cost for the dump fees were between \$200 - \$300 dollars because Pima County increased the landfill fees. The other common areas look good. The summer application of pre-emergent has not yet been applied because the ground is too hard. The landscaper is waiting until there is some rain to soften the ground and then will apply the pre-emergent.

Management Company

It has been extremely quiet. There were a few weeds along the curbing and in the crakes in the road; asked the landscaper to remove them. Discussed with Bruce earlier whether or not have money to due crack filling. Road could definitely use a fog sealing. Pima County had said in the past that if an HOA did the seal coating, the County would do the crack filling. SRMS will follow-up with the County to see if this is still their position. Did find in the file a map with the estimated road footage and a cost estimate (\$17,895) from Pima County to fog seal coat. There is \$39,600 in the Reserve fund. Can look at using some of it and will talk to Pima County to get the roads in better shape.
